Registration and Other Fees

- \$150 Registration Fee per child per class.
- \$50 Supply Fee
- Security Fee per Semester
- **All fees are Non-Refundable and Non-Transferable.**

Tuition Payments

- Enrollment is a 9-month commitment & tuition is divided into 9 equal payments for your convenience. Note: This is not a monthly fee, so all payments are the same regardless of how many instructional days are in the month.
- If you have more than one child in our program, the sibling(s) with the lesser tuition total will receive a 10% discount.
- Annual tuition paid in full by May 1, 2026, will be given a 3% discount.
- Tuition is due on the 1st of the month. A late fee of \$25 will be assessed on the 7th of the month. An additional late fee of \$25 will be assessed on the 13th of the month. Tuition will not be waived for extended absences.
- **April 2026 tuition is paid at the time of registration and is non-refundable.**
- **Schedule of payments is as follows:**
 - **Payment #1** - Registration Fee and Supply Fee – At time of registration
 - **Payment #2** – and Fall Semester Security Fee – due May 1, 2026
 - **Payment #3** – and PAC & Teacher Gift Fund donations – due September 1, 2026
 - **Payment #4** – due October 1, 2026
 - **Payment #5** – and Spring Semester Security Fee – due November 1, 2026
 - **Payment #6** – due December 1, 2026
 - **Payment #7** – due January 1, 2027
 - **Payment #8** – due February 1, 2027
 - **Payment #9** – due March 1, 2027
- **APC Dayschool is a nonprofit organization and operates solely on the funds provided by tuition and fees. Therefore, all payments are non-refundable and non-transferable, even if the class is waitlisted.**
- **If you must withdraw during the school year, 30 days notice is required. No withdrawals after Dec 31st.**

Notes

- Days and Hours of Operation are Monday – Friday, 9:00 am – 1:00 pm.
- We follow the Fulton County Schools for holidays and weather-related closures.
- All classes are determined by your child's age on September 1st.
- All effort will be made to accommodate 1st choice class placements.
- Enrollment is considered complete when the registration fee, supply fee and first tuition payment are paid and enrollment forms are turned in.
- Children in the 3's-TK must be potty-trained.
- APC reserves the right to withdraw any child if we feel that his/her needs cannot be met by our program. The tuition agreement still applies.
- Georgia law requires all children to provide a current immunization record prior to starting the program. Religious exemptions are not accepted, and medical exemptions may be considered on a case-by-case basis with proper documentation from a licensed physician.
- A 30-day written notice is required for withdrawal. No withdrawals after December 31st will be considered.
- Our teachers are CPR and First Aid Certified and complete 10 hours of continued education annually.
